High Risk HT Victim Identification Tool

Purpose: To ensure prevention, recovery and ongoing monitoring to the youth of Jefferson County who are at high risk for commercial sexual exploitation/human trafficking.

Instruction: This tool was created for intended use by professionals who have had training in recognizing High Risk Victims of Human Trafficking and Commercial Sexual Exploitation. These professionals also need to have had training specifically on Identification Tool. The tool is not to be given to the youth or the family to complete.

Examples of "Lingo" associated with human trafficking and commercial sexual exploitation:

- The Life or The Game....The commercial sexual exploitation or the sex industry
- Daddy....Your own pimp (evoking images of fatherhood)
- Ho....prostitute
- P....In reference to another pimp (like Gangsters call each other "G")
- Stable....A group of women/girls under pimp control
- Bottom Bitch/Bottom Girl/Bottom....The head girl
- Breaking....To give all your money to your pimp
- Choose Up....To choose another pimp
- Folks/Family....Your pimp or the person for whom you work
- Track/Stroll/Blade....A street location for commercial sex
- Turnout....Someone who recruits you into "the life"
- Wife-in-Law....A group of girls who work for the same pimp
- Dates/Johns/Tricks....Buyers of commercial sex
- Out of Pocket....To look at or talk to another pimp
- Stay in Pocket....To play by the rules of "the game"
- Squaring Up....To get out of the game
- Renegade....prostitute without a pimp
- Reckless Eyeballing...looking at another black male
- Ho Bag...prostitute's purse
